### **About GNLU, Gandhinagar**

Gujarat National Law University, Gandhinagar (Accreditation with 'A' Grade by NAAC), is a Research-Based Teaching University, established under the Gujarat National Law University Act, 2003, recognized by the Bar Council of India (BCI) and the University Grants Commission (UGC), provides the most diversified and unique teaching, research, training and extension programs. It enjoys membership of National and International network of universities, namely, Association of Indian Universities (AIU), United Nations Academic Impact (UNAI), International Association of Law Schools (IALS), Asian Law Institute (ASLI) and the Shastri Indo-Canadian Institute (SICI).

National Institutional Ranking Framework (NIRF) Ranking 2023 released by the Ministry of Human Resource Development, Government of India ranked GNLU as the 7<sup>th</sup> best law school in the country. GSIRF (Gujarat State Institutional Ratings Framework) ranked GNLU as 'Five Star' University in the Category of law with highest CGPA. GNLU is ranked 4<sup>th</sup> among the top law Institutes in 'Outlook Ranking 2023'. In addition, Week Survey in 'Best Law College' Category also placed GNLU in 4<sup>th</sup> Position during the Year, 2023. . GNLU is ranked 3<sup>rd</sup> best law college in the Country as per 'India Today Ranking 2024'.

### **About GNLU-SILVASSA Campus**

In addition to its GNLU's main Campus situated at Gandhinagar, GNLU also established additional Campus (GNLU-SILVASSA) at Union Territory of Dadra and Nagar Haveli and Daman and Diu (DNH & DD) and the first batch of UG & PG programmes commenced from the Academic Year, 2023-24.

The DNH & DD is the fastest growing Union Territory in India and are acquiring importance both at the national and international level with the commencement of so many international projects across the UT. With the initiative of the Hon'ble President of India, Hon'ble Prime Minister of India and the Hon'ble Administrator, this UT is turning into an education hub, where many reputed institutes have opened their Campuses or also planning to start many more Campuses in the near future.



Apart from education, there has been multi-fold development in this Union Territory in various sectors like entertainment, tourism, and trade etc. Therefore, the need was felt that the imparting legal education is one of the most crucial requirements for the holistic growth of the region since the law graduates are going to play a vital role in the development of the Union Territory of Dadra and Nagar Haveli and Daman and Diu. With the support of the Administration of UT of DNH & DD, the Government of Gujarat and overall guidance of the members of the Statutory Council of the University, GNLU has established an additional Campus at Silvassa from the Academic Year, 2023-24.

## 1. Courses Offered at GNLU for the Academic Year, 2025-26

**Under-Graduate Law Degree Programme:** GNLU offers five years integrated Honours degree programmes i.e., BA LLB(Hons.); BCom LLB(Hons.); BSc LLB (Hons.); BBA LLB(Hons) and BSW LLB(Hons) at its main University, Gandhingar. Out of the total allocation of seats by CLAT Office, further allocation of stream will be done on the basis of merit-cum-preference, subject to fulfilling the eligibility criteria.

**Post-Graduate Law Degree Programme:** GNLU offers four specializations at LL.M programme, namely Corporate and Business Law; Constitutional and Administrative Law; Criminal and Security Law; and Intellectual Property Law at its main University, Gandhinagar. Specialization will be offered only if ten students opted for the particular specialization.

**Horizontal Reservation:**

In addition to the above-mentioned vertical reservation, horizontal reservation of 30% shall be made in favour of female candidates, 5% of seats for Specially Abled Persons/Persons with Disability (PWD) Category and 25% of seats shall be made in favour of candidates of Gujarat Domicile, cutting across all the above categories (Non-compartmentalized), except for EWS category.

**1.2 Admission of Supernumerary (NRI/FN/JK/NEI & Sports Categories) Seats by GNLU**

Apart from the admission & allocation of seats by CLAT Office, the admission under supernumerary seats shall be filled by the GNLU on the basis of CLAT ranking. Interested candidates are required to fill-up separate expression of interest form published by GNLU. The direct admission will be undertaken on basis of applications received by the University using the CLAT ranking. For detailed selection process, candidates are required to refer the notification. NRI category seats are available to NRI candidates or Indian nationals sponsored by NRI as per the Supreme Court Guidelines.

Foreign National (FN) category seats are available to Foreign Nationals only i.e., candidates with foreign citizenship. Candidates seeking admission under the Foreign National category are not required to appear in the CLAT and shall apply directly to the University against the notification. Interested candidates are required to refer the GNLU website for further more details. Unfilled Foreign National category (FN) seats shall be offered to the candidates from NRI Category. The details regarding the eligibility criteria for admission under NEI (North East India) and J&K (Jammu & Kashmir) shall be mentioned in the notification published by the University.

The University also has 4 Supernumerary Seats (2 for Boys & 2 for Girls) under the Sports Quota. The candidates who are interested in seeking admission under the Sports Quota can apply directly to the University and shall be required to fill-up application/expression of interest form. The notification shall be announced on the GNLU website and the candidates are required to refer the notification for detailed selection process. The details of the number of seats available under the supernumerary seats are as follows: -

**Horizontal Reservation:** In addition to the above-mentioned vertical reservation, horizontal reservation of 30% shall be made in favour of female candidates, 5% of seats for Specially Abled Persons/Persons with Disability (PWD) Category and 25% of seats shall be made in favour of candidates of domicile candidates of the Union Territory of Dadra and Nagar Haveli and Daman and Diu (DNH & DD), compartmentalized across all the vertically reserved categories, except for EWS category. The Unfilled seats under the any categories shall be converted as per the decision of the statutory Councils.

**Important Note:**

The NRI&FN-UG Candidates are required to pay INR 1,38,000/- and tuition fees of USD 12,500 and PG Candidates are required to pay INR 1,42,200/- and tuition fees of USD 6000. In addition, USD 2000 and USD 500 need to be paid by UG & PG candidates respectively as one-time development charges. All fees and payable amounts shall be in accordance with the Reserve Bank of India/Government of India guidelines. The above fee structure is only for the Academic year 2025-26 and is subject to revision from time to time by the University and subject to change as per the decision of the Finance Committee/Executive Council of the University.
